July 13th – Present working draft of comprehensive plan to council (at work session) and to staff (hard copy and Dropbox link)

July 14th – Post working draft of comprehensive plan on city website; notify media; notify MPC, Town of Port Royal, Chamber of Commerce, Downtown Merchants Association, HBF, CCL, SICCC, and Neighborhood Associations.

July 14th thru August 20th – Public will be able to electronically submit comments.

July 19th – Discuss working draft of comprehensive plan with MPC.

August 12th – Hold in-person, public sessions: day, from 2pm – 4pm; night, from 5pm – 7pm.

August 20th – Close electronic public comment time for the comprehensive plan.

August 21st thru September 7th – Incorporate comments from council, planning commission, staff, and the public. Create Priority Investment Element.

September 7th – Announce final schedule at Neighborhood meeting.

September 14th – Public Hearing on proposed comprehensive plan.

September 20th – Present draft-final of the comprehensive plan to the MPC.

September 28th – Present draft-final of the comprehensive plan to council at work session.

September 29th thru October 5th – Incorporate final revisions.

October 12th – Present final comprehensive plan to council for approval.
