BACKGROUND INFORMATION:

1. *Terms will range from 1 to 3 years*
 2. *Terms will be staggered for each board/commission*
 3. *Consecutive terms shall not exceed 6 years, except for extraordinary circumstances where the city council believes it to be in the best interest of the community to extend the term for a specified period of time.*
 4. *After at least a 1 year absence, a previous board/commissioner may be appointed to serve the board/commission again.*
 5. *All terms shall end on June 30 of the applicable year.*
 6. *Partial terms of less than 6 months do not count toward the consecutive term limit of 6 years.*
 7. *Vacancies will be filled in the same manner as an initial appointment.*
 8. *Members shall serve without pay, but may be reimbursed for actual expenses incurred in the performance of their duties from available funds approved in advance by the administrator.*
