Vehicles will be available for inspection at the City of Beaufort Public Works, 16 Burton Hill Road, Beaufort, SC 29902 on Monday through Friday during the hours of 9:00 a.m. to 4:00 p.m. Some vehicles are currently being used and may not be on site. Call Public Works at (843)-525-7054 to schedule an appointment so the vehicle(s) you are interested in seeing will be there at your scheduled appointment. Additional information and photos are available on the City's website listed under Appendix "A". Mileage is subject to change as some vehicles are still being utilized at this time.

The City will accept bids of the minimum bid amount or higher. Bids, less than the minimum bid amount, may not be considered. Sealed bids must contain Vehicle #, bid amount, copy of bidder's driver's license, contact number, physical address, and signature of bidder. The Vehicle # must be written on the outside of each envelope. If someone submits bids for more than one vehicle, they must submit each bid in a separate sealed envelope. Highest bidder of each vehicle must deliver payment of an official certified check by 12:00 PM EST on June 13, 2014 to the same delivery address where the bid was originally submitted. Failure to deliver payment by specified time will result in the City contacting next highest bidder with a twenty four hour deadline, excluding weekend hours, to deliver payment. Upon delivery of an official certified check in the amount specified in the sealed bid, the City will turn the "lien free" car title and vehicle keys over to the successful bidder and the bidder may go to Public Works and pick up vehicle.
